In consideration of the mutual covenants contained herein the Subject consents to the use of photographs and/or likeness of Subject heretofore made or hereinafter to be made by SCUMC or representatives thereof, including photographs on any media whatsoever or videography including the Subject. Specifically the Subject refers to the use of videotapes, photographs and/or likeness of Subject, alone or with others, obtained while either on or off SCUMC premises.

SCUMC agrees that the said videotapes, photographs and likeness of Subject will be used solely in the interest of positive representations of SCUMC and only for the purpose of publicity, education and other promotions via brochures, world wide web pages, posters displaying activities of SCUMC, and photographic presentations at church functions supporting SCUMC's ministry programs.
3. I agree that SCUMC is to be the sole owner of all rights and copyright holder of the videotapes, photographs and likeness of Subject for all purposes herein set forth, and that the content of web pages owned by SCUMC shall be in the sole discretion of SCUMC.
4. I understand that I shall receive no financial compensation for the use of videotapes, photographs and/or likeness of Subject.
5. I understand that SCUMC has no control over the subsequent use of said videotapes, photographs and/or likeness of Subject by other parties, after they have been published or used by the SCUMC via brochures, world wide web pages, posters displaying activities of SCUMC, and photographic presentations at church functions supporting SCUMC's ministry programs.
